APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

This report is being written while the world is enduring the tragic impact of COVID 19 and while the future for both Zambia and Scotland are still very uncertain. ZTA along with everyone else, is adapting how we can progress our work in the emerging conditions and we are aware of the increasing importance of support for mental and emotional well-being in these confusing times.

The work of the 2018/19 Capacity Building grant was successfully completed with the Interim and Final reports being positively received by Scottish Government. Our long-term plan to apply for the Scottish Government 3 year project grant was overturned when that grant was withdrawn for review. A decision was made to apply for a further Capacity Building Grant with the focus on the work in Zambia: to build on the development of ZART as an autonomous organization through further input from Challenges Zambia, following positive feedback from the initial workshops and to consolidate the systems of data collection to monitor the practice of TA. We were successful in our application and were awarded £14,850 to pursue the programme.

Last year's work progressed with three further visits to Zambia. In April Liz Hall and Simon Willoughby-Booth were in Lusaka for 3 weeks and a new course on working with children was delivered at University Teaching Hospital (UTH).

In September Joanna Pearce was able to support two weeks training in Livingstone, enabling both another Trainer to be certified and a Master Trainer to be certified to deliver Training of Trainers. Simple data collection systems were agreed at UTH and Livingstone. Follow up was done with participants in the earlier Child training. Information sharing sessions were held with ZART and an agreement outlining roles and responsibilities drafted. They were introduced to ZTA's safeguarding (Continued under Any Other information)

policy. This visit coincided with the workshops for ZART run by Challenges Zambia which were very productive. In discussion with ZART and the Psychology Association of Zambia, it was agreed that the budget for the Case Study training was not sufficient to provide a useful level of training. Later in the year, when it became clear that we would have a large underspend, CORRA allowed a reallocation of funds which enabled a four day training to be arranged and completed in early 2020 as well as an extra visit at that same time to complete the programme. The last visit by Lesley Hill and Joanna Pearce was able to support the Case Study training, review and redesign the data collection systems and deliver training to ZART in Safeguarding relevant to the Zambian context. Links were strengthened by meetings with Mental Health Users Network Zambia, the INGO forum, Centre for Infectious Diseases Research in Zambia (CIDRZ) and CBM. Useful meetings with the Ministry of Health have advanced their commitment to the coordination of the training and practice of Therapeutic Art and have led to a request from them for a proposal from ZART to design the expansion of the training to the provincial centres and hopefully the community service. A review and update of the ZTA manual was conducted.

In addition to the Livingstone training the ZTA course has been delivered at UTH and Chainama College. Due to the impact of COVID 19 it is uncertain when further training will be possible in 2020. Presentations have been made by ZART to private nursing schools at Chainama Hospital and to Renaissance, a private therapy centre in Lusaka. The draft research paper "Enhancing Mental Health Care through the use of Therapeutic Art in Zambia" was presented at the Mental Health Conference in Lusaka and it has now been published in the Med. Journal of Zambia. Based on the work with ZART Challenges funded research into business structures and markets, this will form the basis for the ongoing work due to start over the next months.

In Scotland we have continued to strengthen our systems. A website has been published and online task tracking instituted. Quarterly Board meetings established with a more structured standing agenda. Our internal communications have been rationalized and roles more clearly defined.

We continue to attend Alliance working groups on Fundraising, Safeguarding, MEL and Leave No-one Behind and have attended SCVO and Alliance Conferences and AGMs as well as Scottish Government Grant holders' days. In all we attended 34 in person or online events. In addition, our work was presented as part of a workshop "Africa now and Next" at the first International art therapy research conference.


Recently links with CIDRZ have led to developing a joint research proposal to use Therapeutic Art with HIV positive children and families. Lesley is leading this with a small group of colleagues. We are also involved with Challenges in a proposal for Grand Challenges Canada funding to incorporate TA in programmes for young people facing the transition to employment.

It feels as though the year has continued to consolidate our work on many fronts and though the outlook is so uncertain in so many ways, we have a lot of opportunities opening up and new avenues to pursue.
