Objectives and activities

Charitable purposes

The provision of education - providing training to professionals and students in the use of 'Therapeutic Art'. This will be achieved by providing practice-based training programmes and clinical supervision informed by our pilot programmes, the latest research and global policies in this field, and the in-country needs of communities, the Ministry of Health of Zambia together with mental health and disability organisations in Zambia.

2. To undertake research in order to further explore and establish an evidence base for training in the use of 'Therapeutic Art' and to disseminate findings to add to the mental health knowledge base and policies at local and global levels.
3. To advance health via improvements in patient/client care, which are achieved by the work of professionals trained in Therapeutic Art

Summary of the main activities in relation to these objects

1. Providing training for mental health professionals and students in Zambia to enable them to use Therapeutic Art as part of their practice.
2. Training Zambian trainers to enable them to deliver locally based and sustainable training in Zambia.
3. Developing the monitoring and evaluation of the outcomes of Therapeutic Art training in Zambia and its contribution to local health systems and the establishing a programme of research.
4. Disseminating the outcomes of ZTA's work through publications and presentations.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

A year on and the world is still in the grip of the Covid pandemic. The year has been one of constant adaptation and readjustment but still one of progress and achievement.

Two new Trustees have joined the ZTA Board, Jamie Dale and Caroline Buckland bringing much needed skills and experience. Rachel Bruce has formally withdrawn as Trustee due to ill health. Diana Mintal, who expressed interest in becoming a Trustee has become a volunteer and is working with the Research Group. We are also in the process of engaging volunteers to work with Fundraising and social media.

The Constitution was amended to allow of Board Meetings to be held remotely. An advantage of this has been the regular inclusion of Zambian colleagues in the meetings.

We have divided responsibilities/roles more effectively with Operational, Fundraising/Finance, Research and Digital/social media groups, all answerable to the full Board.

We have begun reviewing the Strategic Plan but the implications of the continuing Covid situation have delayed finalising the timescales needed for forward planning.

We were awarded a grant by the Scottish Government Department for International Development. This Capacity Building grant programme underwent several changes and the money that became available because no trips to Zambia from Scotland were possible, was, in agreement with CORRA, reallocated productively. Our interim and final reports were submitted to CORRA and received favourable feedback. The work with Challenges was successfully completed and ZART is registered now as TAZ (Therapeutic Art Zambia) and is establishing a business model and administrative structures. We were also awarded a micro-grant by The CORRA Foundation to support the development of digital communication tools for TAZ in Zambia. (Cont'd p3)

Achievements cont'd.

Delivery of the ZTA course has been impossible in the context of college closures and the impact on hospitals due to Covid but TAZ members have used their experience to develop an intervention piloted successfully as part of Challenges Youth to Work programme. This has been evaluated and will be adapted to become a regular part of the Programme. 2 members have also been introduced, with colleagues from Tanzania and Botswana to a trauma treatment protocol which we hope to pilot when possible. Implementation of the MoH proposal has been delayed. The reallocation of funds enabled a CPD day for TAZ including digital equipment, some publicity materials, Zoom licences and the piloting of remote training for CIDRZ staff and peer counsellors.

The UK Government decision to cut the Aid budget has had an impact on our funding strategy as the MRC grant and a THET Partnership grant that we were working towards were both withdrawn. The Scottish Government has not yet replaced the Small Grants programme with any funding streams relevant to our work. However Lesley and Liz have been awarded travel grants by MAITS for the CYP training and also some additional funding from Old St Paul's Episcopal Church. There is also an application to Lush awaiting a decision. It is hoped that a trip to deliver this training will be possible early 2022.

The relationship with the University of Edinburgh has been strengthened through a Masters Student placement and it is intended to establish a formal Partnership between ZTA, UoE and CIDRZ to pursue further joint working, research and possible funding applications.

TAZ and ZTA have established a draft 4-year development plan which the Fundraising group will be considering.

A year that could not have been foreseen but which has seen some interesting developments and consolidations as well as disappointments and setbacks.




